No.140, dated 24-04-1984 of Labour Employment, Nutrition and Technical Education Department, Government of Andhra Pradesh to offer Diploma Courses under Engineering and Technology and Pharmacy courses in liaison with All India Council for Technical Education, New Delhi, PCI, New Delhi and Council of Architecture, New Delhi.

All the Government/Aided/Private Polytechnics/Institutions offering Diploma courses in Engineering and Technology in the State of Andhra Pradesh should be affiliated to State Board of Technical Education & Training, A.P. The academic activities, conduct of examinations and award of diploma certificates to the students of all the affiliated Polytechnics/Institutions shall be guided, monitored and regulated by the State Board of Technical Education & Training, Andhra Pradesh (affiliating body), as per the instructions and directions of the Department of Higher Education, Government of Andhra Pradesh from time to time.

All the affiliated Polytechnics/Institutions with SBTET, A.P must follow the curriculum prescribed and published by SBTET, A.P., from time to time ensuring that the student receives quality education that is recognized and widely accepted by all other State Technical Boards in India.

SBTET, A.P conducts academic inspections at regular intervals to monitor the ongoing activities with the standards prescribed by the Department of Higher Education, Government of Andhra Pradesh and AICTE, New Delhi, PCI, New Delhi.

SBTET, A.P conducts board Diploma regular / supplementary examinations and issue marks memos & original diplomas to the eligible candidates studying in the Polytechnics/Institutions for the academic year 2026-27.

SBTET, A.P deutes the staff working in the Polytechnics/Institutions for various confidential works assigned by CHE/ SBTET, A.P, from time to time.

Academic Audit team constituted by SBTET, AP can visit the Govt. Polytechnics/Institutions at any time for academic and examination inspections even without prior intimation. Temporary affiliation accorded will
